CRITERIA FOR NOMINATIONS:

1. Nominations are open to all those who have a balance of experience and skills, follow a Māori philosophy of collective responsibility, and can communicate appropriately with shareholders.
2. No person can be appointed to the committee who is or becomes:
 - a. Mentally disordered;
 - b. An undischarged bankrupt; and/or
 - c. A person convicted of an offence punishable by imprisonment for a term of six months or longer, unless he or she has served the sentence or suffered the penalty imposed.
3. All nomination forms must be signed by the nominee, the person making the nomination and a supporter of the nomination.
4. The nominee, the nominator, and the supporter must be three different people.
5. The nominator and the support person must be shareholders in Owhatiura South 5 Incorporation.
6. Nomination forms must be fully and correctly completed and received by the deadline to be valid.
7. Completed nomination forms may be received in hard copy OR email.
8. The returning officer will determine if the nomination form meets the above criteria.

OTHER RULES RELATING TO THE ELECTION PROCESS:

9. There is ONE position available for election.
10. The returning officer will be appointed by the Committee of Management and will oversee the election process including the announcement of the opening and closing of the election.
11. Elections will be held by secret ballot.
12. The committee members are elected at the Annual General Meeting held on Sunday 11 October 2026. Two vote scrutineers will be appointed by the AGM.
13. The returning officer will announce the election results once satisfied that the process to attain the results has been undertaken in a fair manner.
